

INTERNET PRIVACY POLICY

Personal Information Collected on Serviced Virtual Offices Website

- Information provided on our website is forwarded to a Serviced Virtual Offices agent that will contact you about the services in which you have expressed interest. We may also use your contact information to send you information about other Serviced Virtual Offices products and services.
- Serviced Virtual Offices does not rent or sell visitors' personal information to anyone or other outside companies.

Communications from Serviced Virtual Offices Website

- We will respond to your enquiries and provide information on services you request. We will communicate with you by email or telephone and will make every effort to honour your preference.
- We will occasionally send you information on new products, services, promotions and general information. If you do not want to receive this information, you can opt-out of receiving future mailings by using the unsubscribe link or by emailing us.
